- Photos are selected based on clarity, print quality, reproduction quality, as well as the impression and message it represents.
- Identity of the person submitting the picture will not be available to the person/persons making the final selection of pictures for the calendar until all photos have been selected.
- Each entry must include a photo print or digital disc (no jpg or bmp images accepted unless high resolution). We are looking for a 300dpi or greater for printing reproduction quality. Photos will be returned if requested.
- You can enter one or more photos (there is no limit to the number of entries any employee or member may submit).
- All photos must be received by August 1, 2010.
- There will be one photo selected for each of the 13 months and one for the cover. This is a total of 14 photos selected and \$700.00 total awarded for this contest.
- All winners will be informed by phone and/or by email no later than August 30<sup>th</sup>.
- All members, credit union employees and their families are eligible for the contest.
- All winning photos and negatives become property of Ascentra Credit Union and may be used for future promotional purposes.
- Any people pictured in the photograph must sign a separate consent form, which must be submitted with the entry. Any photos received without an appropriate signed consent form will be disqualified.
- Members name and name location of photo will be printed with each photo selected in the calendar.
