## Contest Rules - 2025 Ascentra Credit Union Credit Card Contest

## **OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE YOUR CHANCE OF WINNING.

**SWEEPSTAKES DESCRIPTION:** The 2025 Ascentra Credit Union Credit Card Contest ("Sweepstakes") is offered in all 50 states and begins at 12:00 AM Central Time ("CT") on 04/01/2025 and ends at 11:59 PM CT on 05/14/2025 ("Sweepstakes Period").

**ELIGIBILITY:** The Sweepstakes Area includes all 50 states and to those who are at least eighteen (18) years of age or older as of date of entry ("Entrant). Employees (and the immediate families [spouses and parents, in-laws, siblings and children and their respective spouses, regardless of where they reside] and members of the same household of such employees, whether or not related) of Ascentra Credit Union ("Sponsor") and their respective parents, divisions, affiliates, dealers, subsidiaries and advertising and promotion agencies and companies involved in the implementation and execution of the Sweepstakes (collectively, the "Sweepstakes Entities") are not eligible to enter. The potential winners will be selected in a random drawing conducted on or about 05/15/2025 from among all eligible Entries received. Potential winners will be contacted by phone and/or email. If a potential winner cannot be contacted or if he/she is otherwise ineligible to receive the prize, an alternate will be selected in his/her place. If the Grand Prize remains un-awarded after three (3) attempts to reach winner, that Prize will not be awarded.
